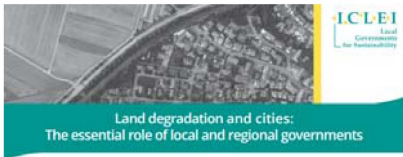

How local action can fight global land degradation?



Global concern for the challenges posed by land degradation has been affirmed by target 15.3 of the Sustainable Development Goals (SDGs), which is aimed at halting and reversing land degradation. Engaging with the challenges posed by land degradation in the 21st century requires a systematic approach that recognizes urban activities as a meta-underlying driver and includes the existing and potential contributions of local and regional governments as part of the solution.

- Land degradation is a pressing worldwide global sustainability challenge. It is increasing at a rate of 5 to 10 million hectares and directly impacts one million and hundreds of millions of people globally.
- There are multiple threats caused by land degradation, it weakens food and water security, reduces biodiversity, undermines natural resources, and can compromise ecosystem services and livelihoods.
- Land degradation has been acknowledged in target 15.3 of the SDGs, which sets the global target for sustainable development from 2015 to 2030. However, the efforts to address the challenge require action at local and regional levels, as well as national and global levels.
- The United Nations Framework to Combat Desertification (UNFCCC), which leads the global effort to reverse land degradation, recently presented a conceptual framework wherein the various actions of local and regional governments can significantly support the goal of halting and reversing land degradation.

Land degradation is a multifaceted and complex issue. The concept of land degradation can be expanded into two major categories: processes and underlying drivers. The processes of land degradation are those drivers that directly affect the land's productivity, such as soil erosion, desertification, and salinization. The underlying drivers are those factors that indirectly affect the land's productivity, such as population growth, land use change, and climate change. Role of Local and Regional Governments a strong theme at the 2017 Global Platform for Disaster Risk Reduction, 22-26 May, Cancun, Mexico

Over 6000 participants convened for the first [Global Platform](#) since the adoption of the Sendai Framework for Disaster Risk Reduction to review the global implementation of the framework. High on the agenda was the 2020 Target E which calls to substantially increase the number of countries with national and local disaster risk reduction strategies.

The role of local and regional governments featured prominently in the discussions – including during remarks in the Opening Ceremony from Enrique Peña Nieto, President of Mexico, and Amina Mohamed, UN Deputy Secretary-General; in the first plenary which featured speakers from Greater Manchester (UK) and Tlalneptla (Mexico); and in several working sessions and side events.

During the preparatory days on May 23, a [Summit of Local and Regional Governments](#) was organized under the aegis of the “Making Cities Resilient” Campaign by UCLG, ICLEI, UNISDR, UN-Habitat, and other stakeholders. The summit showcased local efforts to implement integrated disaster risk reduction strategies and provided an update on the new tools available through the [campaign](#) and campaign partners. Key messages from the Resilient Cities congress were [presented](#) as part of a session on coherent implementing of the post-2015 frameworks. Outcomes from the summit were presented to member states in an official statement presenting the “Declaration of Local and Regional Governments at the 2017 GPDRR.” Follow the links for more information on the event and local implementation of the Sendai Framework.
